

General Privacy Notice for Kickboxinglive.tv

The Kickboxinglive.tv is committed to protecting your privacy and personal data in compliance with the General Data Protection Regulation (GDPR).

Processing personal data

The Kickboxinglive.tv is operated by the CombatTV LLP („data controller”) with registered office in 1103-11871 Horseshow way, 2nd Floor, Richmond, British Columbia, Canada, V7A 5H5.

In the context of certain data processing activities, Kickboxinglive.tv and the continental and national kickboxing federations and live-streaming service provider also process some personal data as **joint controllers** within the meaning of Art. 26 of the GDPR, as the kickboxing associations determine the purposes and means of the data processing, they jointly process. This applies to the organization, holding and management of sporting events, which we always organise jointly with the continental and national kickboxing federations.

You may use **Google Authentication service** to log into your kickboxing account in our website. In such case, Kickboxinglive.tv and Google will become joint controllers of your personal data related to the login process.

If you use your **Facebook account** to your kickboxing account, Kickboxinglive.tv and Meta (Facebook) will act as joint controllers.

You have the right to terminate this connection at any time.

What kind of Data do we process?

- Common Data: for identification like name, surname, address, phone number
- Competition Data: height, weight, gender, category, videos/photos from the competition;
- Account data (name, email, display name, flagged status etc);
- Analytical data: website interactions, user ID, account ID etc;
- Sensitive Data: in relation to its purposes and activities Kickboxinglive.tv can process particular categories of Personal Data (special categories of data);
- Judicial Data: only in the case of collaboration with judicial authority.

For what purposes will be your personal data used?

- *Management of sport Events*: in partnership with local organising committees, kickboxing federations and live-streaming service provider, to ensure the broadcasting, recording and transmission in any digital format and commercial exploitation and licensing of such events;
- Data Processing for statistical purposes;
- maintain a high level of integrity of kickboxing sports;

- *Management and Public Disclosure of Sport-Specific Athlete Data* (in relation to promote the sport of kickboxing and to inform the public);
- *Our legal obligation* is to process your personal data to ensure the protection of athletes' health, contribute to the prevention of fraud and doping control and prevent illegal performance enhancement, and to process your personal data to provide dispute resolution in sports-related disputes between athletes and sports professionals;
- With your consent we will process your contact information for *electronic direct marketing purposes*;
- Providing *information society services* by maintaining certain websites and web applications, analytics and website measurements.

The Recipients of your personal data

The access to your personal data will be provided only for strictly necessary and ancillary activities.

We may share your personal data with our authorised employees, service providers, cooperating partners and national federations, anti-doping agencies, government authorities inside and outside the territory of the European Union. In that regards, appropriate guarantees have been introduced and we maintain the security of your data.

We store your personal data only as long as necessary for the performance of our obligations and strictly for the time necessary to achieve the purposes for which the information was obtained.

Your Privacy Rights

If the related data processing is based on your consent, then you are free to withdraw your consent any time and we will not continue our data processing activity relative to you. The withdrawal of your consent does not affect the lawfulness of prior data processing.

There is not an obligation to provide your personal data. However, should you refuse it, Kickboxinglive.tv will not be able to carry out its activity.

You have the right

- to access your Data;
- to erasure and anonymization of the provided Data;
- to rectification of your Data;
- right to data portability;
- right to opposition and restriction of processing of your Personal Data.

Kickboxinglive.tv is required to have a lawful basis on which to process your data. We rely on the following legal bases when processing your personal data:

- consent you provide us pursuant to Article 6(1)(a) of the GDPR
- to comply with legal obligations under Article 6(1)(c) of the GDPR
- vital interests under Section 6(1)(d) GDPR - in exceptional circumstances, we may rely on the need to protect your vital interests to process certain data, particularly sharing information as needed with medical professionals for safety purposes;
- for our or third party's Legitimate Interest pursuant to Article 6(1)(f) of the GDPR.

International data transfers

Kickboxinglive.tv may transfer your personal data outside of the country in which you are located. Some recipients are located outside of the European Economic Area, in countries for which the European Commission has issued adequacy decisions. In each case, the transfer is thereby recognised as providing an adequate level of data protection from a European data protection law perspective (based Art. 45 of the GDPR).

We have established that all other recipients located outside the EEA will provide an adequate level of data protection for personal data and that appropriate technical and organisational security measures are in place to protect personal data against accidental or unlawful destruction, accidental loss or alteration, unauthorised disclosure or access, and against all other unlawful forms of processing.

If an adequate level of protection of personal data cannot be ensured, we either rely on derogations or shall request your explicit consent relating to any such data transfers abroad.

How can you exercise your right?

You can send your request without any particular formality by emailing to the privacy@kickboxinglive.tv or by writing to our registered address. In every moment, you have the right to address your privacy concerns to the Data Protection Authorities.
