

Terms of Use for kickboxinglive.tv streaming platform

Our service allows subscribers to access and view kickboxing content over the Internet on supported devices. The domain through which our service is provided is kickboxinglive.tv.

1. Ownership and Operation

CombatTV LLP, a company based in Canada with the registered office in with registered office in 1103-11871 Horseshow way, 2nd Fllor, Richmond, British Columbia, Canada, V7A 5H5., operates the kickboxinglive.tv domain and associated services. These Terms of Use govern your access to and use of our services.

2. Service Description

CombatTV LLP provides a streaming service exclusively for kickboxing events. This service is available through various Internet-connected devices, subject to subscription or event-based access. We facilitate billing and payments exclusively via Stripe.

- 3. Membership and Access
- 3.1 Subscription: Our service is available through an event-based subscription model. You need to provide a valid payment method through Stripe to purchase access to our events.
- 3.2 Free Access Events: Certain events may allow access without a subscription, requiring only your email address for entry.
- 3.3 Billing: The fee for each event or subscription is billed through Stripe on the purchase date. The specifics of the billing cycle depend on the nature of the purchased access (one-time event or subscription for multiple events).
- 3.4 Cancellation: You can cancel your access to upcoming paid events anytime before they occur. Payments already made are not refundable.
- 4. Use of Our Service
- 4.1 Eligibility: You must be at least 18 years old to create an account and use our service. Minors should be supervised by an adult when using our service.
- 4.2 Account Security: You are responsible for maintaining the confidentiality of your account information, including your password, and for all activities that occur under your account.
- 4.3 Geographic Restrictions: The content available may vary by geographic location and may change from time to time. We make the service available internationally, but streaming quality and accessibility may vary based on location and available bandwidth.
